- **2. Treasurer's Report:** April read the treasurer's report, noting changes since the last meeting. Aaron Parker made a motion to accept the treasurer's report, Julie Imke second the motion and all voted in favor of accepting the report.

### 3. Committees:

**EOM:** Larry Bedwell is EOM for April. Time and place to be determined. May and June will be the last EOM for this year and the EOY reception will be in July. All the previous 12 month EOM will be in consideration for the Employee of the Year award.

Scholarship and Tuition Assistance & Student Appreciation Lunch: Lunch was a success and there were favorable comments about the menu change (Trip to Italy) and the cost being \$5. Betty took IDR payments prior to the luncheon with sales from IDR's at \$1650, cash sales \$355, totaling: \$2005.00. Student Employment will ship in \$1075 and the cost per plate is \$7.50. 430 plates on the contract, totaling \$3225.00. The difference of \$145 will be absorbed by Staff Council. Jana Nixon was concerned that Aramark broke down one side at 12:40 and then the other side right at 1:30 (a few students didn't get to go through the line, about 5 showed up right at 1:30). The possibility of using a card swipe that generates a "ticket" for the door prize drawing was brought up – maybe next year!

**Staff Appreciation:** There will be a mobile snow cone (location to TBA) from 1:30-3:30 on April 29<sup>th</sup>. Staff get a free cone. Others will be charged \$1

**Staff Development:** EoD, Andrea Porter has received approval for a 30 minute once a month *Brain Break*. The first session will be on 4/29 at 3 p.m. (Location to be announced). Staff Council's part is to provide buffalo cookies.

**Election Committee – Voting ends 4/17** Misty reported that the new process for nominations for staff council has shown a 200% increase in voting. In regards to the campus committees being filled with a staff council representative, Misty will compile a list of committees that staff council serves on and hopefully we can get someone on board.

#### 4. Old Business:
