## Current and Pending (Old) Business

### Committee Updates:

- Joint Faculty Student Committee on Academic Affairs (standing committee) (Speakers: Dr. King)
  - Going to meet with OER committee
  - Meet with Buff Smart
  - Will be presentable by April 24th
- Faculty Handbook (Speakers: Dr. King, Dr. Babb, Dr. Ramos-Salazar, Dr. Craig, Ms. Rausch)
  - Suggestion to be a standing committee
  - Important to have for needed changes to the committee
  - o Dr. Craig moves create standing committee
  - o Dr. Farren seconds motion
  - Ms. Rausch ask for a description of the committee for the website
  - Unanimous vote of approval
- Instructor Promotion (Speakers: Dr. Farren, Dr. Babb, Dr. Franken, Dr. King)
  - Instructors would be happy with text created with the "job security" portion removed
  - o Dr. Terry says will be an equity component to merit pool for the next year
    - College would be holding 5% equity as determined by the dean, for instructors and clinical faculty

  - Poll of who on Senate teaches 3/3 loads
  - o Dr. Terry acknowledges that class size could grow
  - President and Provost prefer 3/3
  - EVPP will not support Teaching Load Modification if Faculty Senate does not support this
  - If the university wants to go R3 had to not be 3/3
  - Some programs have specific classrooms that depend on small class size
  - This will reveal what departments have let overloads become habit, and could lead to planning for the future
  - Make a motion to support the efforts of the EVPP in pursuing a 3/3 load for faculty across campus.
  - Dr. Clark seconded the motion
  - Unanimous vote of approval
