What is the budget situation?

Expects a state budget cut in June

A 5% cut wouldn't be terrible

A 20% cut would be terrible, especially if they make it retroactive

Going to protect the faculty

Expecting enrollment down 15%

What can we do to try to entice WT for the unemployed?

Waiving fees for Graduate students

Currently have 500 new people in the pipeline for graduate students

New Students are getting highly discounted summer classes after they

have enrolled

Should have at least 6 classes

Is currently more optimistic than pessimistic

What will happen with merit?

Doesn't force any path to have a merit pool this year

If we can get through budget cuts and enrollment may have

The Fall and Social Distancing

We plan on being an open campus in the fall

Asked the Deans to work with department heads and associate Deans what classes could be hybrid

Still wants students to have some contact with faculty

Whats the ventilation system like and how does that effect spaces?

A big class room with bad ventilation doesn't help

Want to honor the faculty's method of teaching

Wants to discuss whats the faculty input to plan for the fall

Needs less classes of 40

What can we do online, what can we do on campus

Moving through classes in the halls

Dr. Terry doesn't think class will be the same

First concern is for the faculty.

Risk factor is not as high for most students as it is for the faculty

Faculty may lecture from office through Zoom and not be in the same space as the students.

Are there guideline that the senate wants to put forward?

Wants faculty to be able to say if they are all online.

Will make an effort to contact students, will contact students to evaluate how this is going

What can we do to try to keep students engaged with non academics?

Networking and social aspects of university

Give all students single dorms, no roommates

Before the semester ends we need to send some information to faculty for the fall.
