



#### Meal Plan Details

- Students may access the Dining Hall multiple times each day during operating hours.
- Meal plan meals do not carry over from one semester to another.
- Unused Dining Dollars will roll over from the fall to the spring semester if the student has a spring meal plan; Dining Dollars do not roll over at any other time.
- Each meal plan includes five (5) guest meals, which can also be used by the student.
- Dining Dollars may be used in the Jack B. Kelley (JBK) Student Center Food Court, JBK Convenience Store, Buff Stop, 1910 Grill, or the Dining Hall.

# **University Housing Requirement**

WTAMU is committed to the success of each student. Because of this commitment, the University requires all full-time students (enrolled in 12 or more semester hours) under the age of 20 years to live in University housing during the first two (2) years following their high school graduation. This requirement is based upon high school graduation date, not academic standing based on credit hours.

The housing agreement is valid for one full academic year (fall/spring). Students that fall under the above requirement on the first class day of the semester of initial enrollment / re-enrollment (for each academic year) are required to fulfill their housing agreement for the current academic year. Any exception to this requirement must be requested and approved through the Office of Residential Living.

# Meal Plan Requirement

The University requires all students residing on campus to purchase a meal plan (Silver Meal Plan (160) minimum), during the first two (2) years following their high school graduation (based on the graduation date on file with the University).

Meal plans may be changed *without* an exemption through the last class day of the first week of classes (each semester), assuming the student qualifies for the selected meal plan. Otherwise, the student must apply and be approved for a *Meal Plan Exemption*; approvals are not guaranteed.

\*Meal plans will not be changed after the last class day of the first week of classes.

# **Application Process and Cancellation Deadlines**

To apply, sign into your Buff Portal and click on myHousing.

Applications are processed in date order of completion. Assignments are based on the application completion date, which determines when the student will be able to choose their own room. If a student does not choose their own room by the established deadline, assignments will be made at random by the Office of Residential Living.

In order to receive a refund of the housing deposit, students must submit a cancellation request through their *myHousing Portal and* meet the requirement described in the housing agreement. Requests must be received *prior* to the following dates:

Fall – June 1 Summer I – May 15 Spring – Dec. 15 Summer II – June 15

All cancellations after these dates will forfeit their deposits, even if a completed application was submitted after these dates. The *only* instance in which the University refunds a deposit after these deadlines is if the student is **not admitted** to the University for academic reasons.

\*Deposit refunds are mailed to students, unless direct deposit has been set up through the University Business Office, and may take up to six weeks to be processed.

# Housing/Meal Plan Exemptions

All exemptions to the University housing and/or meal plan requirements must be documented and approved by the Office of Residential Living.

The WTAMU housing agreement is valid for one full academic year (fall and spring). All housing exemption requests must be submitted by August 1; students admitted to the University after this deadline may submit an exemption request up to the first class day of the semester. Meal plan exemption requests must be submitted no later than the last class day of the first week of classes. Students requesting an exemption after the above deadlines will not be released from their housing and/or meal plan agreements. Submission of requests does not guarantee approval; students will be contacted via WTAMU email regarding the approval/denial of an exemption request.

Exemption forms and additional information are available at the Office of Residential Living and their website. Students should not make arrangements to live off campus until approved by the Office of Residential Living. Students without an approved exemption will be held responsible for room and/or meal charges.


Please note that exemption processing takes a *minimum* of three weeks, assuming adequate information is submitted. The length of the review process depends on the type of request submitted, as well as the volume of previously submitted exemption requests.

# **Payment Options**

Housing and Meal Plan charges are added to ONE student bill, on the same payment plan selected for tuition and fees, and is paid through the University's Business Office. The housing deposit (\$150) is paid electronically in the *myHousing portal* when the housing application is started. The deposit is not part of the residence hall cost and is separate and apart from any scholarships or financial aid received; therefore, it cannot be waived.
