Dear Intern of the Year Committee:

Magali has been an intern in the Accounting Department for the City of Amarillo for over a year. During her time with the City she has been assigned specific projects and has been instrumental in assisting other accountants with their duties. Work-related duties include assisting the cashiers and reviewing the daily cash reports to reconcile daily cash deposits to receipts. This not only taught her an accounting skill of giving assurance to the posting accuracy, but also helped her get an understanding of governmental accounting and the relationship between various funds. Magali assisted the banking accountant by helping with cleared checks from our general fund bank account. Approximately 2000 checks are written out of this account each month so the process of clearing those checks in our system can be time consuming and attention to detail is very important and must be accurate. To further her exposure to accounting functions Magali has been given the responsible for doing thirty-five bank account reconciliations monthly. These are small accounts some of which do not have much activity but it is still important in maintaining accurate bank balances. Magali is not only responsible for the reconciliation but the research involved in determining what certain items are and what is needed in order to get them to clear out or corrected. Once the reconciliations are done they are reviewed by the Assistant City Auditor and any questions must be resolved through the review. All accountants are expected to be able to answer questions and this is an important tool in learning accounting. Magali has been able to complete these reconciliations timely and she has been able to produce accurate reconciliations as verified through the review process. The transition of assisting the banking accountant to being held responsible for the thirty-five bank reconciliations has been a challenge for her but has helped her grow in her understanding not only of accounting in general, but in governmental accounting. The task requires knowledge of not only the various bank accounts within the City, but the accounting software and the ability to use it for research as well as an understanding of the use of transfers between various accounts. The challenge in reconciling accounts is being able to do the research to determine where the money may have been deposited or the receipt has been posted and determining what needs to be done to correct. Now that Magali has been able to reconcile the smaller accounts timely and accurately she is now

assisting with the general fund bank account which is proving to be more of a challenge. Because of the number of transactions that go through this account each month the reconciliation process is demanding and without attention to detail can be very challenging. The general fund bank account has approximately 1500 deposits or credits each month and 200 additional debits other than the thousands of cleared checks.

Other work-related responsibilities are making selected journal entries to post interest on bank accounts and fund transfers for the health and flex plans. Magali also makes the entry to post the City's ATM activity and calculating the surcharge amount the City expects to receive from the ATM activity.

While reviewing the daily Cash reports and researching the items in question she has been able to assist the cashier responsible for the reports with suggestions on how to show items so they are better explained on the reports.

Magali has been a great asset to the department. She is great at questioning items when they do not agree or balance and has been very helpful in helping the cashiers with some of their questions and has been able to help with the cash receipt reconciliations. Magali has been able to prioritize her work and produces good quality work. She has been eager to try anything that is has been given to her and during each new task she questions the duty sufficiently to get the answers she needs.

Magali is very involved at the University level gaining recognition through several scholarships and awards. She is also active in University organizations and is involved in the community by volunteering in several non-profits in the Amarillo and Canyon area.

Overall Magali has been a great person to work with. She is always eager to take on new responsibilities and maintains a positive attitude throughout. It appears with each new task assigned to her that her confidence and ability to perform the tasks improves and her co-workers have come to respect her. I see her to continue to grow in the Accounting field and will do well in her future career.
