Welcome/Call to Order

OER: Strategies to reduce costs would be ideal. Setting a goal would be beneficial as measurable progress. Can be facilitated by the Joint Faculty-Student Committee on Academic Affairs.

There was much discussion

EVPP: Academic side of the organization is the central role of this position. The institutions finances are directly tied to this and will be a focus of the new role. The EVPP will have the ability to stand with the VPs and be the "first among equals" in this regard. President's role is 75% leadership/external, 25% management/internal. EVPP is 75% internal/management, 25% external/leadership. Committee needs to make sure to take out those that are not qualified. Ideal list will be 3-6 to close from. They are not in place to determine the EVPP, but are there to determine who will NOT be the EVPP.

Fees and impacts on students: Our spending per student is low compared to others based on THECB data. Fees being too low could lead to issues with lacking quality. Fees too high make us unappealing to students.

Blog: Some have found a post offensive. We have tried to rectify this. I have to be careful how I say things and what the impacts are.

Visits to the South Plains: They are going well. Meeting with the Mayor of Lubbock next week. Students come to WT from the South Plains to get away and still get a quality education. We probably have a trade deficit with more going South than them heading North.

Other: Editor of Lubbock Avalanche and Amarillo Globe editorial page. We have a regular production of op.eds. If you want to be a part of this, you are encouraged to write a 700 word op ed and send it to the editor, Doug Hensley.
